# Chairperson's and CEO's Address

Dear Member

It is our privilege to present the Chairperson and Chief Executive Officer's report on behalf of Peer Based Harm Reduction WA's Committee of Management (COM), and on behalf of the volunteers and staff of the organisation.

Peer Based Harm Reduction WA is the state's only peer-based Alcohol & Other Drug service-delivery organisation, providing a range of innovative and consumer-driven health and harm reduction services. The organisation was originally established by, and all of our programs are run by and for, people who use or have used drugs. As such, Peer Based Harm Reduction WA is uniquely positioned to provide a voice for people who use drugs, to represent their needs and concerns, and to support their rights as health consumers. We aim to bring the insights and perspectives of our peers into all of our work, to our partnerships with other organisations, and to the advice and advocacy that we provide to governments and policy makers.

The 2022 - 2023 financial year has seen the retirement of our long-serving CEO Angela Corry. We would like to thank Angela and acknowledge her years of dedicated service to the organisation. On behalf of the COM we welcomed Paul Dessauer into the role of CEO from February 2023. Paul has a wealth of experience in peer-based initiatives and a sound commitment to the values of the organisation.

Our programs continue to evolve and expand to better support the health and human rights of people who use drugs and to contribute to Australia's hepatitis C elimination goals. Our core funding from Sexual Health and Blood Borne Virus Programs at the Health Department of WA has allowed us to continue providing the largest needle & syringe program in the state and to deliver person-centred health services for people who inject drugs. During the months of March to June we conducted community engagement work in the South West Region thanks to a small additional grant from the Health Department of WA, and this work will inform the planned expansion of our Mobile Health Clinic activities in the region. Our Overdose Prevention and Peer Naloxone contract with the Mental Health Commission concluded in June, with a new Community Take Home Naloxone Peer Delivery and Outreach Service commencing in its place, further increasing our capacity to provide naloxone anywhere in the community to anyone who might suffer or witness an overdose. We would like to acknowledge these funding bodies, which enable Peer Based Harm Reduction WA to continue providing a range of unique services which increase the health equity of our consumers.

This year we welcomed three new Committee of Management (COM) members: Professor Simon Lenton, Dr Stephen Bright, and Dr Jessamine Soderstrom. We would like to take this opportunity to thank the long standing and new COM members for their support and for their diligent oversight of the organisation. Our COM has ensured that Peer Based Harm Reduction WA continues to work within its Strategic Plan, meet its obligations, manage its finances, and operate transparently, while maintaining its quality certification under the Alcohol and other Drug and Human Services Standard.

On behalf of the COM and the management we would like to sincerely thank our Finance Manager, Sai Thia, and our Finance Officer, Stevie Davies, for their diligent commitment to ensuring the positive financial outcomes and systems improvements that have been achieved over the 2022 - 2023 financial year. We also extend our appreciation to all staff members for their significant contributions to the important work that Peer Based Harm Reduction WA does.

### FINANCIAL SNAPSHOTS FOR THE 2023 FINANCIAL YEAR

#### **Operating Revenue**

- There were no significant changes in the state of affairs of the Association during financial year 2022 - 23.
- Operating Revenue in 2023 was \$2.11M with no real movement against the prior year.
- Total revenue has increased more than \$170K over the last 5 years (or 1.7% per annum).



#### **Revenue Source**

Grants remain the primary source of funding for Peer Based Harm Reduction WA services, representing 85% of the total revenue in FY2023. Department of Health WA provides 90% of the Association's service program funding, with the remaining 10% provided by the Mental Health Commission WA.

## NSEP and Outreach

Peer Based Harm Reduction WA (PBHRWA) delivers the largest needle and syringe program in the state. Our Needle and Syringe Exchange Program (NSEP) consistently distributes more than 1/3 of all injecting equipment that is provided in WA each year, via our Perth & Bunbury fixed-site NSEPs and our SW Mobile NSEP van, via Outreach NSEP (delivered to-the-home throughout >30,000 km2 of the greater Perth Metro Area and the South West Region), and by our Postal NSEP service (available to consumers anywhere in WA).

Our models of delivery are purposely designed to overcome barriers and to maximise accessibility for anyone who might need our services. Outreach NSEP has the ability to deliver to where the consumer is, instead of expecting them to come to us, and our programs are staffed by peer workers, which enhances engagement, greatly increasing our consumers' confidence and trust in the service. These two factors combine to make NSEP and the harm reduction education that accompanies it much more accessible to our consumers. Since the advent of the SARS-CoV-2 pandemic an increasing proportion of needles and syringes are provided via outreach. Since March 2021, the proportion of N&S delivered in the greater Perth Metro Area via outreach-to-the-home has roughly doubled.

Over the last 6 years, PBHRWA distributed an average of 1.92 million needles & syringes per annum. During this year, our combined NSEP services provided 38% of all needles & syringes distributed in WA.

## Overdose Prevention and Take Home Naloxone

PBHRWA was the first agency in WA to pilot take-home-naloxone, with a peerbased project that commenced in January 2013. The program has adapted and evolved ever since, with PBHRWA remaining by far the largest take home naloxone provider in the state. During the last year PBHRWA provided an average of 110 naloxone devices per month to people who are at risk of suffering or witnessing an opioid overdose. Naloxone is provided by peer workers, accompanied by brief education (<10 mins) on how to recognise and respond to opioid overdose. 24% of naloxone provided in Perth and the South West was delivered in outreach settings, typically delivered to the person in their home. 76% of people who receive naloxone from PBHRWA are returning for replacement devices, and 78% of those are replacing devices that have been used to reverse an overdose in the community.

In June our existing contract ended and was replaced by a new agreement which will allow our Overdose Prevention and Take-Home-Naloxone Project Officer to recruit volunteer peer educators who will be trained and authorised to provide naloxone via brief education. The new project also facilitates increased provision of naloxone in outreach settings, to further increase the accessibility of this simple, life-saving initiative.

# **Health Clinic**

PBHRWA Health services are delivered via our Health Clinics (co-located within our Perth and Bunbury fixed-site NSEPs), and are also delivered in the community via Outreach Clinics to consumers' homes, and at Mobile Health Clinic Van sites.

PBHRWA Health Team is led by our Nurse Practitioner, who is based at the Perth Office, with a Registered Nurse operating the South West Clinic. Nursing staff are supported by HCV Case Management workers operating from our fixed-sites in Perth and Bunbury. These peer workers are trained to deliver preand post-test counselling and to perform phlebotomy and point-of-care-testing. As outreach workers, they can help people to access testing and treatment and provide ongoing assistance in the community, supporting people to remain in treatment until they clear the virus. This is an essential component of our Health Team's person-centered Model-of-Care and acts to make testing and treatment much more accessible.

A total of 438 new patients and 620 returning patients were seen in this twelve month period.



PBHRWA continues to provide Mobile Health Clinics in the Perth Metro area and the South West Region.

During this year, PBHRWA Health Team partnered with workers from Department of Health WA and the Metropolitan Communicable Disease Directorate to deliver a series of Mobile and Outreach Clinics in the Perth metro area. These utilised our Perth Mobile Heath Clinic van and Peer Workers to facilitate the provision by Health Department staff of COVID-19 and influenza vaccinations, and of testing and treatment for HIV and syphilis. **PBHRWA** Peer Workers recruited consumers for the clinics and provided point-of-care-testing for hepatitis C. These clinics were very successful collaborations which highlight the effectiveness of our Health Team's unique approach.



## Perth HCV Case Management

Between July 2022 and June 2023 our Perth HCV Case Management worker provided services to our consumers on 846 occasions. 165 of these were times the worker engaged with people who were new to our Health Team's services.

The HCV Case Management worker supported 27 people to commence HCV treatment and continued to provide assistance and support in the community throughout their treatment journey.

In addition to providing education about HCV testing and treatment and providing telephone and home-visit support to patients, the worker homedelivered DAA medication to people 30 times, took blood samples on 46 occasions, and conducted point-of-care testing for HCV 195 times.



It has been an exciting 12 months for the South West Team, with everyone working to provide the best service possible to all our consumers, and with the promise of enhancing and expanding our operations into the future.

From March to June of 2023, WA Health provided a small grant which supported additional activities designed to improve engagement with the communities in the South West. We initiated this by engaging willing NSEP consumers from small communities throughout the region to participate in focus groups and consultations. Participants described some of the barriers that people who inject drugs in smaller communities face and suggested strategies to help make services more accessible. Confidentiality concerns are greatly amplified in smaller communities, which is why PBHRWA provides health and harm reduction services via outreach, (whether this is in the person's home, at a safe meeting place of their choosing, or in a community setting). This project forged new relationships and provided valuable insights, informing our plans to expand our Mobile Health Clinic operations over the next four years and to simultaneously increase the accessibility of NSEP, take home naloxone, and harm reduction education in the region. To further these plans, the South West Team have been working to build relationships with relevant local agencies and have provided Mobile Health Clinics offering STI & BBV testing services at a number of community events in towns throughout the region. These activities have further developed our connections to community and highlighted the need for confidential and nonjudgmental services to be available equitably to all people regardless of their circumstances.

All of the Team's hard work can be clearly seen in the 2022-2023 data: the South West Team saw 2,344 occasions of service (up 35.4% from the previous year), providing more than 226,000 needles and syringes (an increase of 31.5% on 2022). The South West Health Clinic saw 311 patients throughout this year, 131 of whom were new to the service. The SW Clinic provided hepatitis C treatment to 7 people, and vaccinated 67 people against hepatitis A & B.

We have a fantastic team based at the Bunbury office and each of them is dedicated and proud to work with and for the people who access our services.
